Mrs. Weyer stated the newsletters have been sent, via postage and email. Mrs. Weyer will also have a January newsletter regarding the bill in the State legislature for disbanding villages. Mrs. Weyer also stated she has not heard from Firelands IT.

There was a discussion on the Cement Street park costing the Village money for upkeep and in the future look at selling the park as there is currently little use of the park by the public.

Mr. Smith stated he will update is budget spreadsheet.

Mrs. Crawford thanked the residents for approving the levy. Mrs. Crawford stated she has no update from ODOT.

Mr. Nicholson mentioned the gas leak on Lester Street.

Beth St.Clair,resideing at 117 Depot St. and Steve Cooley, also residing at 117 Depot St. stated they have had water in their basement and want to know what Council is going to do to fix the issue. Scott Miller, who resides at 211 Depot St. also stated he was had water in his basement and wants something done to resolve the problem. Mayor Johnson stated he will contact Bob Biglin and have him look into the issue.

There was a discussion on the fire extinguishers in the Village buildings as they will need to be updated. Zoning Inspector Tom Johnson stated the debris in the maintenance building located at 314 Cement needs cleared out. Mrs. Weyer Made a Motion to Remove the Old Spoiled Debris That is No Longer Needed.
