The Village of Castalia Council met in Regular Session on November 25, 2025 at 7:00 p.m. at the Village of Castalia Hall located at 126 Main Street, Castalia, Ohio. **Mrs. Crawford Made a Motion to Approve Ordinance #2025-10. Mrs. Artrip seconded the motion. Roll Call: Mrs. Crawford, yes; Mrs. Artrip, yes; Mrs. Weyer, yes; Mr. Smith, yes; Mr. Nicholson, yes. Motion carried.**

Zoning Inspector Tom Johnson stated 711 Main St. and the McDougall property look as though the properties are being cleaned.

Bob Biglin stated Franklin Sanitation was on Depot Street investigating the issue. Biglin stated there is an issue on Barden Street with a resident parking on the wrong side of the street especially during snow season and a letter needs to be sent to the resident. Mayor Johnson stated he will contact the resident. Mr. Biglin stated he should have it towed.

Mr. Biglin stated the guard rail estimate for the accident is \$5,455.00 and he has submitted it to the insurance company.

Mayor Johnson stated after the roads in the Village are done Council needs to look at the storm sewers. Mr. Biglin stated a storm sewer should be cleaned each year. Mayor Johnson stated he will be out of the country until December 6, 2025.


