

ORDINANCE NO. 2022- 21 ____

AN ORDINANCE REESTABLISHING THE RATE OF COMPENSATION FOR THE POSITION OF ZONING INSPECTOR FOR THE VILLAGE OF CASTALIA, OHIO, REPEALING ALL ORDINANCES AND RESOLUTIONS INCONSISTENT HEREWITH, AND DECLARING AN EMERGENCY.

WHEREAS, the Council of the Village of Castalia has previously adopted an ordinance establishing the compensation for the position of Zoning Inspector for the Village of Castalia, Ohio; and

WHEREAS, the Council has determined it is necessary to reestablish the rate of compensation for the position of Zoning Inspector for the Village of Castalia, Ohio; and

WHEREAS, the Council has determined to it is also necessary to repeal all ordinances and resolutions inconsistent herewith and replace them with this ordinance; and

WHEREAS, due to the proximity of the effective date of the change in compensation for the position of Zoning Inspector, January 1, 2023, the Council has further determined that an emergency now exists regarding the aforesaid. Therefore, it is deemed advisable to declare this ordinance to be an emergency measure, the rate of compensation for the Zoning Inspector being directly related to the health, safety, and welfare of the Village of Castalia, this ordinance shall take effect immediately upon its adoption and due authentication by the Mayor and Village Fiscal Officer of the Village of Castalia, Ohio; and

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CASTALIA, STATE OF OHIO:


SECTION 1. That commencing on January 1, 2022, the Council has determined the position of Zoning Inspector shall be compensated the sum of Two Hundred Dollars (\$200.00) per month for each month worked.

SECTION 2. That all ordinances and resolutions inconsistent herewith are hereby repealed and replaced with this ordinance.

SECTION 3. That this Council hereby finds and determines that all formal actions relative to the adoption of this Ordinance were taken in an open meeting of this Council and that all deliberations of this Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public in full compliance with applicable legal requirements, including §121.22 of the Ohio Revised Code.


SECTION 4. That the establishment of the compensation of its employees being a matter of local self-government, the Council has determined that the reestablishment of the compensation of the position of Zoning Inspector is directly related to the immediate preservation of the health, safety, and welfare of the Village of Castalia. Therefore, this

Ordinance shall be adopted as an emergency measure to take effect immediately upon its adoption and due authentication by the Mayor and the Fiscal Officer, respectively.
