

ORDINANCE NO. 2022- 20

AN ORDINANCE DECLARING THAT ONE 2004 FORD F550 SUPER DUTY TRUCK WITH PLOW AND ONE SIXTEEN-FOOT TRAILER OWNED BY THE VILLAGE OF CASTALIA, OHIO, ARE NO LONGER NEEDED FOR MUNICIPAL PURPOSES, AND DECLARING AN EMERGENCY.

WHEREAS, the Council of the Village of Castalia, Ohio, has determined the 2004 Ford F550 Super Duty Truck with plow and one sixteen-foot trailer owned by the Village are no longer needed for municipal purposes due to them being obsolete, not needed, or unfit for public use; and

WHEREAS, the Council has also determined that the estimated value of said vehicles are in excess of One Thousand Dollars each, and therefore, it is necessary to sell said personal property owned by the Village to the highest and best bidder pursuant to the requirements of *§721.15(D) of the Ohio Revised Code*; and

WHEREAS, the Council has further determined that it is necessary to authorize and direct the Village Fiscal Officer to advertise the sale of said vehicles for not less than two or more than four consecutive weeks in a newspaper of general circulation within the Village of Castalia, Ohio; and

WHEREAS, Council has further determined that is necessary for the immediate preservation of the public peace, health, safety, and welfare and that said personal property shall be sold without delay and therefore dictates that this ordinance be adopted as an emergency measure to take effect immediately upon its adoption and due authentication by the Mayor and the Fiscal Officer, respectively; and


NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF CASTALIA, STATE OF OHIO:

Section 1. That the Council hereby determines that one 2004 Ford F550 Super Duty Truck with plow and one sixteen-foot trailer, both having an estimated value in excess of One Thousand Dollars, are no longer needed for municipal purposes due to them being obsolete, unneeded, or unfit for public use. Therefore, the Council has further determined that one 2004 Ford F550 Super Duty Truck with plow and one sixteen-foot trailer should be sold on behalf of the Village pursuant to the highest bidder. The minimum purchase price shall be not less than \$2,000.00 for each vehicle. Said vehicles shall be sold in an "as is, with all faults" condition with no warranties whatsoever to the highest bidder pursuant to *§721.15(D) of the Ohio Revised Code*.

Section 2. That the Council has further determined that it is necessary to authorize and direct the Village Fiscal Officer to advertise the sale of said vehicles for not less than two or more than four consecutive weeks in a newspaper of general circulation within the Village of Castalia, Ohio.


Section 3. That this Council hereby finds and determines that all formal actions relative to the adoption of this Ordinance were taken in an open meeting of this Council, and that all deliberations of this Council and of its committees, if any, which resulted in formal action, were taken in meetings open to the public in full compliance with applicable legal requirements, including *§121.22 of the Ohio Revised Code*.

Section 3. That the Council has determined further that in order to provide for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the Village of Castalia, Ohio, it is necessary to sell the aforementioned vehicles that have been determined to be no longer needed for municipal purposes, as soon as possible, and as such, this Ordinance shall be adopted as an emergency measure to take effect immediately upon its adoption and due authentication by the Mayor and the Fiscal Officer, respectively.
