Meeting Minutes

The Village of Castalia Council met in Regular Session on April 22, 2025 at 7:00 p.m. at the Village of Castalia Hall located at 126 Main Street, Castalia, Ohio. The meeting was called to order by Mayor Jim Johnson with the following in attendance: Jim Johnson, Barb Weyer, Si Nicholson, Jake Smith, Cindy Crawford, Georgia Artrip, and Fiscal Officer Kathy Niehm.

Mrs. Weyer Made a Motion to Approve the Minutes of the April 8, 2025 Minutes. Mr. Nicholson seconded the motion. Roll Call: Yeas, unanimous.

Mayor Johnson stated the roof replacement with Damschroder will probably be in middle or late May, depending on the weather.


There was a discussion on the Lowell, Bardwell, Lucas Intersection Plan. There was also a discussion on the IT plan.


Mrs. Weyer stated she thought the yard waste program was going well.
